 - iii) The required average annual construction turnover shall be greater than Tk. 850.00(Eight Hundred Fifty) Lakh in the last 5 (Five) years.
 - iv) The minimum amount of liquid asset i.e working capital or credit line(s) of the Tenderers shall be Tk 140.00 (One Hundred and Forty) Lakh (adequacy of minimum liquid assets i.e working capital substantiated by any scheduled Bank of Bangladesh in the format as specified Form PW3-7 (CPTU STD PW3) (Failing to submit in PW3-7 will make the tender non-responsive).
 - v) The minimum Tender capacity shall be: Tk 430.00(Four Hundred Thirty) Lakh
 - vi) Tenderers having quoted the tender price more than 10% (Ten) percent above or below the official cost estimate, the tender will be rejected.
