- a. The tenderer shall have minimum 10 (ten) years of general experience in construction works (year counting from the date of publication of IFT)
 - b. The tenderer must have an experience in successful completion of at least 1 (one) number of RCC frame structure building construction work having at least 5-storied pile (pre-cast/cast in situ) foundation including civil, sanitary and internal electrical works with a value not less than Tk.30.00 (thirty) crore through a single contract during last 5 (five) years in any Government/Semi-Government/Autonomous organization of Bangladesh. (year counting from the date of publication of IFT)
 - c. In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that locality /District under whose jurisdiction the work has been done
 - d. The tenderer must have a minimum average annual construction turnover of Tk.35.00 (thirty five) crore over last 5(five) years (year counting from the date of publication of IFT)
 - e. The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk 9.00 (nine) crore only
 - f. The minimum tender capacity shall be Tk. 42.00 (forty two) crore only
 - g. The tenderer shall submit updated income tax clearance certificate, VAT registration certificate, Trade licence, ABC category contractor and supervisory license from Electricity Licensing Board
 - h. The tenderer shall be installed a batching plant at the project site before starting the construction work.
 - i. The tenderer shall maintain the pro-rata progress of works (in terms of value of the works) as part of his obligation pursuant to GCC clause 42
