In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that locality /District under whose jurisdiction the work has been done

d. The tenderer must have a minimum average annual construction turnover of Tk. 45.00 (forty five) Crore over last 5(five) years (year counting from the date of publication of IFT)

e. The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk.10.00 (ten) Crore

f. The minimum tender capacity shall be Tk.45.00 (forty five) crore

g. The tenderer shall submit updated income tax clearance certificate,VAT registration certificate,Trade licence, ABC category contractor and supervisory license from Electricity Licensing Board

h. Successful tenderer shall install a batching plant at the project site before starting the construction work.
