(ii) In case of work done by any Government, Semi-Government or Autonomous organization of Bangladesh other than PWD, the certifying & authenticating authority will be the officer of the organization not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done. (c) The required average annual construction turnover shall be greater than Tk.200 (Two hundred) lac during the last 5 (five) financial years. (d) The minimum amount of liquid assets or working capital or credit facilities of the tenderer shall be Tk. 50 (Fifty) lac only, supported by Bank Certificate (Original Copy only).
