**Eligibility of Tenderer :**

- 1) Reputed Contactors/Construction firms with general experience for min. 5 (Five) years.
- 2) Must have successfully completed at least 1 (One) RCC building including civil, sanitary & E/M works under any Govt./semi Govt./Autonomous Body of Bangladesh during last Five years (counted backward from the date of publication of IFT) amounting at least Tk. 2.50 (Two and half) Crore in a single

contract.

3) For works done under PWD, the certifying authority shall be the concerned Executive Engineer. For works done under any Govt./Semi Govt./Autonomous Body other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer

4) Minimum avg. annual construction turnover of TK 12.00 (Twelve) Crore supported by payment certificates for works during last Five years.

5) Minimum Liquid assets/credit facility of Tk. 3.00 (Three) Crore. Adequacy of minimum liquid assets substantiated by any scheduled Bank of Bangladesh as specified in the format (attached with tender document), without any alteration, issued not earlier than the publication date of this IFT.

6) Minimum Tender Capacity of 2.50 (Two and half) Crore.

7) The Tenderer must enclose with tender valid VAT Registration certificate, TIN/Tax Clearance certificate, updated Trade license and updated ABC & Supervisory license issued by the Electrical Licensing Board of Bangladesh.

8) Tender and evaluation proceedings will be conducted in accordance with the latest rules of PPR and its amendments and Tenderers are expected to submit their rates and documents accordingly.
