(b) The minimum specific experience as a Prime Contractor of at least 1 (One) Contract of 1 (one) Building Construction work completed within the last 5 (Five) years in Government/ Semi-Government/ Autonomous Organization of Bangladesh, of a value of at least Tk 75.00 ( Seventy Five) Lac. (i) In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer, under whom the work has been executed. (ii) In case of the work done under any Government/ Semi-Government/ Autonomous Bodies/ Organization other than PWD, the certifying authority shall be an officer not below the rank of Executive Engineer. (c) The required average annual construction turnover shall be greater than Tk 286.00 (Two hundred eighty-six) Lac. over the last 5 (Five) years in the Government/Semi-Government/ Autonomous Organization of Bangladesh. (d) The minimum amount of free fund (liquid assets) i.e working capital or credit facilities of the Tenderer shall be Tk 72.00 (Seventy-two) Lac . Document of Liquid Assets submitted along with the tender must be issued between the publication date and the submission date of the tender. A certificate of unconditional Liquid Asset must be Submitted as a letter of commitment from the Bank for a line of credit to the Tenderer in favor of the work in the form PW2a-3, otherwise, the tender will be summarily rejected. (e) ) The Tenderer must have an up-

to-date Trade License, Income Tax Clearance Certificate, eVAT Registration License, and all necessary documents.

(f) The minimum Tender Capacity of the Tenderer shall be 105.00 (One hundred five) Lac.
