(a) General experience: Reputed Contactors/ Construction firms having general experience in construction works for minimum 05 (Five) years.
(b) Work experience: Must have successful completion of at least 1(one) number of Supplying and Installation of 5.0 Kwp Off grid Solar Panel system work in Bangladesh under Government/semi Government /Autonomous Organization during last 05 (Five) years for minimum Tk. 12.00 (Twelve) Lakh in a single tender. Last 05 (Five) years will be counted backward from the date of publication of IFT .
In case of the work done under PWD, the certifying and out hunting authority shall be the concerned Executive Engineer. In case of the work done under any Govt./semi Govt./autonomous bodies other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same certificate will be duly verified by the concerned Executive Engineer of PWD of the District under whose jurisdiction of the work has been done in the format as attached with the tender document.
(c) The Tenderers shall have a minimum average annual construction turn over during last 05 (Five) years for TK. 35.00 (Thirty Five) Lakh.
(d) The minimum amount of unconditional free funds (liquid assets/ cash flow capacity/ credit facilities) Tk. 11.50 (Eleven Point Five) Lakh.
(e) Tenderer must have following certificates: Valid & Up to date Trade license, Up to date TIN certificate, Up to date Income Tax certificate (2017-18), Up to date VAT Registration , Up to date ABC category Electric License from Bangladesh Electric Licensing Board.
