- iii)The tenderers shall have a minimum average annual Construction turn over during last 5(five) years Tk.20.00 Crore Supporting documents is to be submitted with the tender.
- iv) Having minimum liquid asset amounting Tk.3.00 Crore, supporting documents is to be submitted with the tender.
