(c) The required average annual construction turnover shall be greater than Tk. 560.00 (Five Hundred and Sixty) Lac over the last 5(Five) years in any Government/Semi-Government/ Autonomous Organization of Bangladesh.Payment certificates for contracts in progress/completed under the public sector must be submitted along with tender supporting annual average construction turnover. (d) The minimum amount of free fund (liquid assets) i.e. credit facilities of the Tenderer shall be 150.00 (One Hundred Fifty) Lac.
