C) The Minimum Amount of Financial Resources as Liquid Asset or Working Capital or Credit Line(s) or Specific Credit Commitment or in Any Combination of them, of the Tenderers shall be Tk 30.00 (Thirty) Lac. (Must be Issued Within Publication of IFT in e-GP System to the Last Date of Lodgment of the Tender and must be Followed by the Appropriate Format in the Form of e-PW2A-8).
