Only payment certificated will be considered for turnover calculation. No completion certificate will be treated as payment certificate. The Tenderer must submit a summarized Turnover Calculation sheet of last 3 years.
 - The minimum amount of free fund (Liquid asset) or working capital or credit facilities of the tenderer shall be Tk.50.00 (Fifty) lac. Document submitted along with the tender must be issued in between publication date and submission date of the tender b.
