The minimum specific experience as a Prime Contractor or Subcontractor or Management Contractor in construction of at least 01 (one) contract of RCC Frame Structrue Building (3-storied building with pile foundation), Internal & External Sanitary & Electrification Works successfully completed within the last 5 years, each with a value of at least Tk 16.50 (Sixteen Point Five) Crore in a single work order/tender in Government/ Semi Government/Autonomous Organization of Bangladesh in standard work completion format attached in eTD.
4. The tenderer shall have a minimum average annual construction turnover during last 5 (Five) years of Tk 17.00 (Seventeen) Crore Payment Certificate(s) must be submitted as evidence of turnover.
5. The minimum amount of liquid asset or working capital or credit line(s) of the tenderer as mentioned in ePW3-8 shall be Tk 4.50 (Four Point Five) Crore.
6. The minimum Tender Capacity shall be Tk 19.00 (Nineteen) Crore.
