The minimum specific experience as a Prime Contractor or Subcontractor or Management Contractor in construction of at least 1(one) contract of similar nature of Works successfully completed within the last 5 years, with a value of at least Tk 1.60 (One point Six Zero) Crore in a single work order/tender in Government/Semi Government/Autonomous Organization of Bangladesh in standard work completion format attached in eTD.
 4. The tenderer shall have a minimum average annual construction turnover during last 5 (Five) years of Tk 2.00 (Two) Crore. Payment Certificate(s) must be submitted as evidence of turnover.
 5. The minimum amount of liquid asset or working capital or credit line(s) of the tenderer as mentioned in ePW3-7 shall be Tk 1.25 (One point Two Five) Crore.
 6. The minimum Tender Capacity shall be Tk 2.00 (Two) Crore.
