Eligibility of Tenderer :

- The minimum number of years of general experience of the Tenderer in Construction Works as Prime Contractor shall be 5 years.
- The minimum specific experience as a Prime Contractor of at least 1 (One) number of RCC Building work amounting to Taka **9.00 (Nine)** crore completed within the last 5 (Five)

years in Government/Semi-Government/Autonomous Organization of Bangladesh (i) In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer, under whom the work has been executed. (ii) In case of the work done under any Government/ Semi-Government/ Autonomous Bodies/ Organization other than PWD, the certifying authority shall be an officer not below the rank of Executive Engineer.

(c) Average annual construction turnover shall be greater than Taka **16.00 (Sixteen)** crore over the last 5 (Five) years in the Government/Semi-Government/ Autonomous Organization of Bangladesh supported by payment certificates.

(d) The minimum amount of free funds (liquid assets) i.e. working capital or credit facilities of the Tenderer shall be Taka **4.00 (Four)** crore. Document of Liquid Assets submitted along with the tender must be issued between the publication date and the submission date of the tender. Certificate of unconditional Liquid Asset must be in the form of a letter of commitment from the Bank for the line of credit to the Tenderer in favor of the work in the form PW3-7.

(e) The minimum tender capacity shall be Tk. 11.00 (Eleven) crore only.

(f) The tenderer must have updated VAT, IT, Trade License, ABC category Electrical license & supervisory license

(g) All other conditions as mentioned in TDS & PCC of e-tender document must be fulfilled.
