 3. The Tenderer shall have minimum average annual construction turnover during last 5 (five) years. BDT 130.00 (One hundred Thirty) Crore Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.
 4. The minimum amount of liquid asset or working capital or credit facilities as PW3-7 format of the tenderer shall be BDT 26.00 (Twenty six) Crore.
