In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that locality /District under whose jurisdiction the work has been done
  - d. The tenderer must have a minimum average annual construction turnover of Tk. 50.00 (fifty) Crore over last 5( five) years (year counting from the date of publication of IFT)
  - e. The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk.13.00 (Thirteen) Crore
  - f. The minimum tender capacity shall be Tk.55.00 (fifty five) crore
  - g. The tenderer shall submit updated income tax clearance certificate,VAT registration certificate,Trade licence, ABC category contractor and supervisory license from Electricity Licensing Board
  - h. Successful tenderer shall install a batching plant at the project site before starting the construction work.
  - i.The tenderer shall maintain the pro-rata progress of works (in terms of value of the works) as part of his obligation pursuant to GCC clause 42
