- (c) The required average annual construction turnover shall be greater than Tk.10.00 Lac in the last 5 years.
- (d) The minimum amount of liquid assets i.e working capital or credit facilities as PW2a-3 format of the Tenderers shall be Tk 7.00 (Five) lac.
