(b) Specific experience as a Prime Contractor/Sub Contractor/Management Contractor in successful completion of at least 1(one) number of work of minimum Tk. 75.00 (Seventy five) lakh in a single contract in Government / Semi-Government / Autonomous Organization of Bangladesh during last 5 (five) years. In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer. In case of work done under any Government/Semi-Government/Autonomous/Organization other than PWD, the certifying authority shall be an officer not below the rank of Executive		

Engineer and the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done.

(c) The Tenderer shall have a minimum average annual construction turnover of Tk. 90 (Ninty) lakh during last 05 (five) years. Total certified payments received for contracts in progress or completed contracts under public sector during last 5 (five) years must be submitted along with the tender in support of average annual construction turnover.

(d) The minimum amount of liquid asset or working capital or credit line(s) of the Tenderer shall be Tk. 25.00 (twenty five) Lakh. Document submitted along with the tender must be issued in between publication date and submission date of the tender.

(e) The minimum Tender Capacity shall be Tk. 75 (Seventy five) lakh.

(f) The Tenderer must possess: Up-to-date income tax clearance certificate, VAT registration certificate, Up-to-date trade license.
