  - (b) Having minimum experience as a prime Contractor or Subcontractor or Management Contractor in successful completion of at least 1 (one) number of building with gymnasium or auditorium of BDT not less than 2800.00 (Two Thousand and Eight Hundred) Lac in a single contract within last 10 (Ten) years in any Government/Semi-Government/Autonomous organization of Bangladesh.
  - (c) The tenderers shall have a minimum average annual construction turnover during last 5 (five) financial years of Tk. 4000.00 (Four Thousand) Lac.
  - (d) The minimum amount of liquid asset or working capital or credit facilities of the tenderer shall be Tk. 1000 (One Thousand) Lac. In case of credit facilities/Line of Credit must be unconditional and the document submitted along with the tender must be issued in between publication date and submission date of the tender. Letter of Commitment for Bank's Undertaking for credit facilities/Line of Credit as per form PW3-7 without any alteration uploaded in CPTU website must be submitted for this purpose.
  - (e) The minimum tender capacity shall be Tk. 3000.00 (Three Thousand) Lac.
  - (f) The contractor shall maintain the specified pro-rata progress.
