 - c) The Tenderer must possess: (i) Up-to-date valid Trade License renewed till FY 2023-24, (ii) Up-to-date Income Tax clearance Certificate till 2023-24, (iii) Valid VAT registration Certificate, iv) Up to date A B C category Contractor and Supervisory License from Electricity Licensing Board renewed till 2022-23.
 - d) The required average annual construction turnover shall be greater than Tk 27,00,00,000.00 over the last 5 years as specified in the TDS.
 - e) The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk 5,50,00,000.00 from any Scheduled Bank, net of other contractual commitments in between publication date and submission date as specified in the TDS.
