  - c) The tenderers shall have a minimum average annual construction turnover during last 05 (five) years of **Tk. 3.00 (Three point Zero) crore**. Payment certificates for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.
  - d) The minimum amount of liquid asset or works capital or credit facilities of the tenderer shall be of **Tk. 2.00 (Two point Zero) crore**. Document submitted along with the tender must be issued in between publication date and submission date of the tender.
