- (b) Having experience as a Prime Contractor or Subcontractor or Management Contractor in successful completion of at least 1(one) Number of Repair / Maintenance or RCC building construction works of minimum Tk. 200 Lac (Two Hundred Lac) in a single contract in Government/Semi-Government/Autonomous Organization of Bangladesh during last 05 (Five) years. In case of the work done under PWD, the certifying and authenticating authority shall be the concerned Executive Engineer.In case of the work done under any Government/Semi-Government/ Autonomous Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer and the same duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done.
- (c) The tenderer shall have a minimum average annual construction turnover Tk. 500.00 lac (Five Hundred Lac) during last 5 (five) years . Payment certificate for contracts in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.
- (d) The minimum amount of liquid assets or working capital or credit facilities of the tenderer shall be Tk. 200 Lac (Two Hundred Lac).Document submitted along with the tender must be issued in between publication date and submission date of the tender. Letter of Commitment for Bank's Undertaking

for Line of Credit as per form PW3-7 of Tender and Contract forms section must be submitted for this purpose.
