(C) The Tenderer must have a minimum **average annual construction turnover** during last 5(five) years amounting of **Tk 200 lac** with necessary supporting documents from the concerned authorities(work certificate).

(D)The minimum amount of **Liquid Assets or working capital or credit facilities** of the tenderer shall be **Tk.190 lac**. Adequacy of minimum liquid assets or credit line(s) substantiated by any scheduled Bank of Bangladesh only in the format as specified by CPTU (Form PW3), without alteration, issued not earlier than **twenty One (21)** days prior to the day of the original deadline for submission of Tenders for this contract.

(E) Minimum **Tender Capacity must be Tk.270 Lac** in case of JV tender capacity required for leading and other partners shall be as described in TDS.
