- (b) The minimum specific experience as a Prime Contractor in similar nature works (Boundary wall) of at least 01 (One) contract successfully completed in Government/ Semi-Government/ Autonomous Organization of Bangladesh within last 5 (five) years with a value of at least Tk 90.00 Lakh (Tk .Ninty Lakh). Number of years will be counted backward from the date of publication of IFT in the newspaper.
- (c) The minimum average annual construction turnover shall be greater than Tk 1.50 Crore (Tk One crore fifty lakh) in the last 5 (Five) years. Payment certificates of tenderers in progress or completed under public sector during last five years must be submitted along with tender. Turn-over shall be counted as years counting backward from the date of publication of IFT in the newspaper.
- (d) The minimum amount of liquid assets in form of working capital or credit facilities of Tk.70.00 lakh (Tk .Seventeen lakh). In case of Line of credit, certificates must be unconditional and specified for this work only submitted in the prescribed form of CPTU from any scheduled bank.
- (e) The minimum Tender Capacity shall be Tk 90.00 Lakh (Tk .Ninty Lakh).
- (f) Up-to-date Trade License, Income Tax clearance and VAT registration certificate must be submitted.
