A) Reputed contractors/construction firms who have minimum 5 (Five) years of general experience in Construction works.

B) Having experience in successfully completion/execution of at least 1(one) number of similar nature of construction work including Civil, Sanitary and other works worth not less than Tk.85.00 (eighty five ) Lac only in a single work order in Government/Semi Government/Autonomous Organization of Bangladesh during last 5(five) years. As well as having tender capacity of Tk.90.00 (ninety ) Lac only and tender security of Tk 3.00 (three) Lac with tentative duration of completion 4 (four) month.

C) The required average annual construction turnover shall be greater than Tk [110.00(one hundred and ten) Lac] during the last [5(Five)] years. Payment certificates of works contract in progress or completed under public sector must be submitted along with tender in support of average annual construction turnover.

D) The minimum amount of Liquid Assets i.e. working capital or credit Line(s) of the tenderer shall be Tk. 45.00 (forty five) Lac supported by Bank certificate which should be counted 28 (Twenty Eight) days before from the date of opening of tender.

E) Up-to dated Trade License, Income Tax Clearance and VAT Registration Certificate

F) All other conditions as mentioned in (Section-2 & Section-4) of tender documents must be fulfilled.

Special Instructions: i) According to ITT clause no. 43.3, Tenders having quoted the offer in percentage is more than 10 (Ten) percent above or below the official cost estimated of the proposed works, shall be rejected.
