(B) Having experience in successfully completion/execution of at least 1(one) number of similar nature of works worth not less than Tk. 160.00 (One Hundred and Sixty) Lakh in a single work order/tender in Government/ Semi Government/Autonomous Organization of Bangladesh during last 5(five) years in standard work completion format attached in STD.

(C) The Tenderer shall have a minimum average annual construction turnover during last 5(five) years amounting of Tk. 475.00 (Four Hundred and Seventy Five) Lakh. Payment certificate will be counted only.

(D) The minimum amount of free fund (liquid asset) ie. working capital or credit facilities of the tenderer shall be Tk. 232.00 (Two Hundred and Thirty Two) Lakh only.
