2. The minimum specific experience in construction works of at least 01 contract of Similar nature building construction works successfully Completed within the last 05 (Five) years, with a value of at least TK.960 Lakh.

3. The required average annual construction turnover shall be greater than Tk 16 crore over the last 5 (Five) years. Payment certificate for contracts (only Government/Semi Government/ Autonomous Organization) in progress or completed must be submitted along with tender in support of average annual construction turnover.
4. The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk. 600 Lakh (must be in the form of PW 3-7 in original form).
