Necessary supporting documents shall be submitted with the tender. Any estimated cost or contract value will not be considered to calculate Average Annual Construction Turnover. - d) The tenderder must have a minimum amount of free funds (liquid Assets) /Credit facilities, working capital Tk. 250.00 (Two Hundred Fifty) Lakh only.
