  3. The required average annual construction turnover shall be greater than Tk. 800.00 (Eight hundred) Lac in the last 5 (Five) years. Payment certificates for contract in progress or completed under public sector during last 5 (five) years must be submitted along with the tender in support of average annual construction turnover.
  4. The Tenderer must have a minimum liquid assets/ working capital/credit facilities (in the PW3-7 form without any alteration) Tk. 300.00 (Three hundred ) Lac.
  5. The Tender Capacity is Tk. 850.00 (eight hundred fifty) Lac. Supporting document must be submitted along with information as per enclosed form (ongoing works/commitments)
  6. The Tenderer must enclose VAT registration certificate, Up-to-date Income Tax clearance certificate, Up- to-date Trade license and Up-to-date ABC Contractor and Supervisory License.
