 - In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that locality /District under whose jurisdiction the work has been done
 - The tenderer must have a minimum average annual construction turnover of **38.00 (thirty eight) Crore** over last 5(five) years (year counting from the date of publication of IFT)
 - The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk.7.00 (seven) Crore
 - The minimum tender capacity shall be Tk. 28.00 (twenty eight) crore
 - The tenderer shall submit updated income tax clearance certificate,VAT registration certificate,Trade licence, ABC category contractor and supervisory license from Electricity Licensing Board
 - Successful tenderer shall install a batching plant at the project site before starting the construction work.
 - The tenderer shall maintain the pro-rata progress of works (in terms of value of the works) as part of his obligation pursuant to GCC clause 42
