  - In case of the work done under any Govt/ Semi Govt/ Autonomous Bodies/ Organization other than PWD the certifying authority shall be an officer not below the rank of Executive Engineer & the same duly verified by the concerned Executive Engineer of PWD of that locality /District under whose jurisdiction the work has been done
  - The tenderer must have a minimum average annual construction turnover of Tk. 35.00 (Thirty five) Crore over last 5( five) years (year counting from the date of publication of IFT)
  - The minimum amount of liquid assets or working capital or credit facilities of the Tenderer shall be Tk 8.00 (eight) Crore only
  - The minimum tender capacity shall be Tk. 35.00 (Thirty five) crore only
  - The tenderer shall submit updated income tax clearance certificate, VAT registration certificate, Trade licence, ABC category contractor and supervisory license from Electricity Licensing Board
  - The tenderer shall be installed a batching plant at the project site before starting the construction work.
  - The tenderer shall maintain the pro-rata progress of works (in terms of value of the works) as part of his obligation pursuant to GCC clause 42
