Pile foundation including internal sanitary and electrification works having the value of Tk. 500.00 (Five hundred ) lac in a single tender in any Government/Semi-Government/Autonomous Organization during last 5(five) years. c) The experience certificate for successful completion of work shall have to be issued by the officer not below the rank of Executive Engineer of concerned Department/Organization duly verified by the concerned Executive Engineer of PWD of that district under whose jurisdiction the work has been done. d) The minimum amount of free fund (Liquid asset) or working capital or credit facilities of the tenderer shall be Tk.120.00 (One hundred twenty) lac. Document submitted along with the tender must be issued in between publication date and submission date of the tender.
